### Description of Work:

1. Electrical Utility Power Assessment

2. Electrical Receptables Assessment
  - a. I shall assess each receptable + GFI and test their condition, terminations + performance.
3. Electrical Meter Ground Rod Electrode Assessment
  - a. I shall assess your ground rod to measure its resistance to confirm it's under 25 ohms.
4. Electrical Water Main Ground Electrode Assessment
  - a. I shall assess your water mains electrode to measure if current is running through the piping.
5. Electrical Panel Assessment
  - a. I shall assess your electrical panel(s) per their full load current and energy consumption.
6. Electrical Lighting + Power (EMF) Assessment
  - a. I shall assess the electrical magnetic fields with all electrical loads powered + operational.
7. Electrical Wireless (RF) Assessment
  - a. I shall assess the radio frequency field with all electrical wireless devices activated.

### Processing and Procedures:

2. Assessment Data Analyzation
